**DUTIES OF DELEGATES**

1. Each delegate shall arrive in time to register as an official delegate to the Representative Assembly (RA), with both the California delegations and NEA.
2. Each delegate shall attend all caucuses of the California delegation and check in with the pre-designated APT leader upon arrival to each caucus. Normally the caucus begins at 7 a.m. daily. Delegates must be registered with the California delegation to participate in the caucus. Delegates are expected to remain through the convention.
3. Each delegate shall attend all business meetings of the R.A.
4. Each delegate is strongly encouraged to attend NEA budget committee hearings, resolutions committee hearings, speeches by prominent national figures, etc.
5. Each delegate shall consider CTA State Council and caucus position when voting.
6. Each delegate shall sit with his or her Service Center Council delegation on the RA floor or inform the appropriate person where he or she will be seated to ensure communication regarding RA business and/or personal emergency information of concern to the delegate, as well as to verify attendance.
